The first upgraded AN/TYQ-23(V)4 TAOM was shipped to Camp

Pendleton on October 22, 1999

Litton Data Systems is under contract to upgrade 31 Marine Corps AN/TYO-23(V)1 TAOM shelters to the AN/TYQ-23(V)4 OCU Workstation configuration. This new configuration replaces the full mil-spec OCUs with COTS based workstations. A Fibre Channel Local Area Network, other COTS hardware and software improvements are also incorporated.

The upgrade program, referred to as OCU Production, was awarded in September of 1998. The first production configuration upgrade successfully completed in-plant First Article testing and was shipped to MCTSSA, Camp Pendleton, on 22 October 1999 for a 60 day Government-conducted First Article testing.

Ten TAOM systems are in Agoura, have completed refurbishment under the Inspect & Repair Only As Necessary (IROAN) phase of the contract and are currently in various stages of disassembly in preparation for installation of the OCU Production upgrade kits. \Box

DSD Receives Low Rish Y2K Rating from Corporate

Following an audit of Data Systems' Year 2000 Compliance Program, Tony Garcia, Baan and Y2K Program Director, was notified that the Division is in compliance with the Y2K requirements of the Litton Corporate Y2K Committee.

Eighteen domains were assessed, including PCs and servers, product/contract support systems, testing and test documentation, awareness and training, project management, critical vendors/suppliers, off-site facilities and ERP, financial, payroll, engineering and facility systems. All earned a low Y2K risk rating

According to Tony, "Because the Y2K problem affects everyone at DSD, we called upon many people to help ensure we would be ready when the calendar changed Being ready meant identifying every product we ever delivered to a cus-

tomer, determining if it had a Y2K problem, and then coming up with a plan to fix the problem. We also had to check all our internal support and business systems, both hardware and software, and repair or replace them as necessary, which is why we chose the Y2K compliant Baan ERP system. We had to ensure that all of the vendors who supply us with parts, software, or utilities were providing Y2K compliant products. That meant that for more than a year, we had to track thousands of items at all three sites and chart their progress toward Y2K compliance. In the product area, we were fortunate in that we only had a few products with problems, and we were able to correct those early on. In the business systems, we replaced over 400 of our legacy business systems with the Baan system. Several of our facility systems, including our e-mail system here at Agoura and the voice mail system in San Diego, had to

Litton Industries, Inc. has completed the sale of selected assets and liabilities of its Litton Enterprise Solutions (LES) subsidiary to Acxiom Corporation in an all cash transaction. Acxiom Corporation is headquartered in Little Rock, Arkansas It provides a wide spectrum of data products, data integration services, mailing list services, modeling and analysis and information technology outsourcing services, as well as data warehousing and decision support services to major U.S. and international firms.

Litton Forms Interconnect Technologies Division

At the dedication of a \$65 million, 75,000 square foot expansion to its manufacturing facility in Springfield, Missouri on November 3, 1999, Litton Chairman, President and Chief Executive Mike Brown also announced the formation of Litton Interconnect Technologies division, which joins together Litton's Advanced Circuitry, Inter-Pak Electronics and Interconnection Products divisions and establishes a single, recognizable identity to further Litton's unique strengths in meeting the needs of the printed circuit industry Litton Interconnect Technologies is a division of Litton's Electronic Components & Materials group.

TASC Awarded GSA ID/IQ Contract with Potential Value of \$100 Million TASC was awarded a contract by the General Services Administration (GSA) enabling the company to provide a wide range of professional engineering services to U.S. government agencies through the Federal Supply Schedule. This indefinite delivery/indefinite quantity (ID/IQ) contract has a five-year period of performance with a five-year option period. Over the first five years, the potential contract revenues to Litton could be worth up to \$100 million. The Professional Engineering Services (PES) Schedule may be used by federal agencies and the city of Washington, D.C., allowing agencies to obtain services that span all phases of engineering, such as strategic planning for technology programs; concept and requirements development; systems design, engineering and integration; test and evaluation; integrated logistics support; and acquisition and life-cycle management.

Standards of Conduct: Gratuities

The following article was provided by John Crigler, Director, International Business Development.

Litton's policy concerning gratuities is stated clearly in Division Standard Practice 1000, 1009-13, Personnel Practice #300-2, and Material Service Center Operating procedure 11 01. Our business standards can be summarized by the guiding principle all division business shall be conducted ethically, honestly and with integrity. It is presumed that all employees will conduct themselves accordingly

When it comes to gratuities, there are

many times when "horse sense" applies in addition to company practices. Not only must we abide by our policy, we must also ensure that we give the appearance of complying. For example, if one were to join an old friend, who happens to be a customer or vendor, in a lavish nightclub (with the understanding that we pay our own way) and we were seen by a competitor, it could be the basis for a protest of a contract award. This is not to say that we can't visit with dear friends, but it does remind us of the necessity of discussing these incidents ahead of time with our supervisor and of documenting the circumstances when it may appear to outsiders that gratuities may have been exchanged

One example of when the acceptance

of a gratuity is appropriate is when it is offered by a foreign visitor. Japanese and Arabs are particularly apt to offer gifts. Rather than offend the giver, graciously accept the present on behalf of Litton and then discuss it with your supervision and/or our division attorney. Depending on the circumstances, it may be determined that you keep the gift, display it in a division showcase, donate it to charity or return it.

The rule is that we are not allowed to give gratuities to customers or receive them from vendors. However, situations will arise where the proper response may not be clear. When you have a question about what to do, consult with your supervision, Human Resources or the Law Department.

be replaced. Since many of our computers and workstations were older systems with Y2K problems, we replaced more than 400 of them

"Thanks to the diligence of all of the employees who participated in this process, we were able to meet the corporate goal, and complete our Y2K efforts on schedule. It was extremely important for us to meet our corporate goal since

Litton Industries wanted to state to all of their customers that we had identified and corrected all of our Y2K problems, and that they could continue to rely on our products. Even though the calendar change occurred on January I, that does not mean that our job is over. We have to maintain our vigilance and ensure that we continue to remain Y2K compliant throughout the year."

Litton Reports FY2000 First Quarter Results

For the first fiscal quarter ended October 31, 1999, Litton reported diluted earnings per share of \$1.07; compared with diluted earnings per share of \$1.01 for the first quarter of fiscal 1999. The reported earnings for the first quarter included the effect of a one-time cumulative accounting change that reduced earnings by \$2.8 million, or \$0.06 per share After this non-cash accounting change, net earnings were \$50.0 million versus \$47.2 million. Revenue for the first quarter was \$1.37 billion, compared with \$1.21 billion for the comparable period of the prior year.

"Litton's results met our expectations and represent another solid quarter for the company," said Michael R. Brown, chairman, president and chief executive officer. "In addition to the company's improved revenue and earnings, all segments improved their backlog of business for the first quarter compared with the fourth quarter of last year."

Highlights of the quarter included

The acquisition of Avondale Industries, Inc. on August 2, 1999 for a per-share price of \$39.50 or \$529 million in cash Avondale joins Ingalls Shipbuilding division in the Litton Ship Systems (LSS) group. With annual revenues of approximately \$1.8 billion and 17,000 employees, LSS is now the largest builder of non-nuclear ships for the U.S. Navy

Congress formally authorized \$375 million for the initial development and construction of the LHD 8 amphibious assault vessel. The project is now slated to begin in 2000, five years earlier than originally scheduled.

The Electronic Components and Materials group expanded its global connector business through Litton's acquisition of TEC Electrical Components Group Ltd. of Middlesex, England TEC has about 110 employees and reported annual revenues of approximately \$8.6 million.

In the Information Systems group, Litton PRC and Litton TASC won major contracts with the General Services Administration, Defense Supply Service and the U.S. Navy's East Coast Tactical Training Range Complex. These multi-year contracts have a potential value to Litton of approximately \$248 million.


